**Explanation:** (Apologies for the size of the charts).

**The First Chart is a Chart of Expenses**. We spent \$70,298.49 for the Calendar Year 2023. That included slightly more than \$28,000 in contracted services for regular Lay Minister, Tech Support, Office and Grounds Assistance, the Music Minister and RE personnel, and for Cleaning Services. The remaining large expenses were for utilities (about \$7,000), UUA Contribution (\$4,000), our Insurance (now \$5,254 per year), and Speakers (\$4,340). Other large expenses were to cover general building maintenance, and to help Memorial Fund by paying some of the capital improvement expenses related to finishing the water mitigation program and basement renovation, and for window restoration.

Last year, we gave \$1,475 to the United Way Committee for Unmet Needs, \$2,607.44 to Donate-a-Plate and \$1,256 to misc. charities and other causes such Pride in the Park, Juneteenth and MLK Day.

## In income, members and friends were very generous in 2023. Thank you!

For Income: Total Income was \$76,565.27. Last year, contribution though all sources of **individual** giving totaled nearly \$54,000. In this Fiscal Year thus far, we have reached nearly \$29,000 in individual giving. This is 54% of the of a 12 month period which is excellent. Fund Raisers for Calendar Year 2023 account for approximately \$8,500 after expenses.

At the end of the Calendar Year, there was a net in income of \$6,266.78, and at this stage in the Fiscal Year, we have \$13,999.02 more in income than in expenses. This provides us with a healthy buffer for upcoming large expenses expected through the winter months in utilities, and with the need to meet our annual UUA contribution and to cover the new insurance bills for the remaining of the year (Total insurance from November 2023 to October of 2024 is \$5,254).

Needless to say, it is through the generosity of our members and friends that we are able to do so much.

**Things left to do:** We will convert our single Money Market account at Mercantile to a long term CD and into a smaller, more available short term CD (the Finance Committee recommended a 2/3's to 1/3 split between long and short term CD's). As of this writing, bank balance stands at \$96,139.07 (Money Market account), and \$16,843.59 is in the Checking account.

We are converting to an office based accounting system in full, no longer using QuickBooks by the end of this month. Our in-house system is simpler and more accurate (or at least less confusing). We must file our state tax report for a 501c-3, and distribute 1099-NEC's before 1/31/2024. (We are using Beers Tax Service). "Donations Made" letters will go out to all members and friends within the next two weeks. This year, the reports about donations will be much more accurate, as both a calendar and a fiscal data base are up to date. All in-kind contributions have been noted where possible. This incudes where someone has not accepted a speaker's fee, and has donated their fee back.

**Things completed:** We use a yearly subscription to QuickBooks. That will be terminated at the end of January, but our Microsoft word program app will be renewed. The Corporate status of the Church has been renewed for the next 25 years, with an updating of the Corporate Officer (Michael Drew as officer of record – Thank you, Michael)! Finally, our tax exempt status has also been renewed.
